Dear Ms. Lipton:

I refer to your FOIA request dated December 29, 2016, to the FBI for the release of certain material under the Freedom of Information Act (Title 5 USC Section 552). Of the relevant documents retrieved in response to your request, three were considered to be of primary interest to the Department of State, and were therefore referred to us for appropriate action.

After carefully reviewing these records, we have determined seven pages are appropriate for release in part, the excisions, requested by the FBI, are exempt from disclosure pursuant to:

- 5 U.S.C. § 552(b)(6), which concerns material the release of which would constitute a clearly unwarranted invasion of an individual's personal privacy.
- 5 U.S.C. § 552(b)(7)(C), which concerns records or information compiled for law enforcement purposes the release of which could reasonably be expected to constitute an unwarranted invasion of an individual's personal privacy.

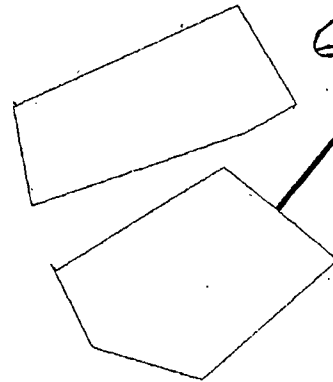

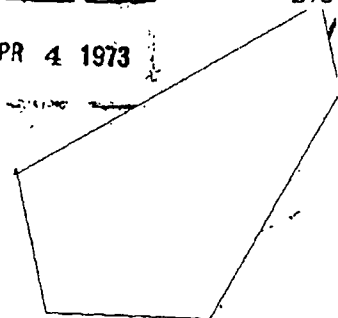

1. NEA/PAB IN TOUCH WITH SY AND PAK EMBASSY MARCH 24 AND AGAIN TODAY REGARDING THREATENING LETTER RECEIVED BY PAK EMBASSY. COPY OF LETTER PICKED UP TODAY BY FBI LIAISON. WHILE WE HAVE NOT YET SEEN IT, PORTIONS READ BY DCM RIZA PARALLEL PARA ONE REFTTEL.

2. SY HAS ARRANGED WITH EXECUTIVE PROTECTIVE SERVICE TO PROVIDE QUOTE FIXED POST UNQUOTE SECURITY AT PAK AMBASSADOR'S RESIDENCE FOR FEW DAYS AND QUOTE CLOSE WATCH UNQUOTE ON CHANCERY. 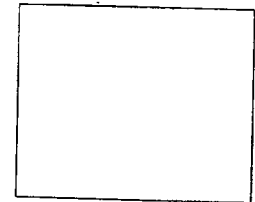

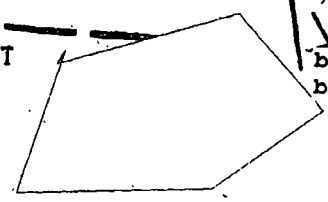

1. MFA DIRGEN ZAKI INFORMED CHARGE MARCH 26 THAT PAK EMBASSY WASHINGTON HAS RECENTLY RECEIVED LETTER ADDRESSED TO AMB SULTAN KHAN, SENT BY QTE NATIONAL YOUTH ARMY UNQTE AND MAILED FROM INDIA. LETTER THREATENED THAT AMB KHAN WOULD BE KILLED UNLESS HE LEFT US BY MARCH 25. IT ALSO THREATENED LIVES OF THE TWO CHILDREN OF PRES BHUTTO WHO ARE NOW STUDENTS AT RADCLIFFE/HARVARD.

2. ZAKI STATED THAT PAK CHARGE RIZA HAD INFORMED US QTE SECURITY AUTHORITIES UNQTE BUT DID NOT KNOW EXACTLY TO WHOM INFORMATION HAD BEEN PASSED. THREATENING LETTER WAS RECEIVED FOLLOWING AMB KHAN'S DEPARTURE FROM WASHINGTON TO ATTEND PAK CONSORTIUM MEETING LAST WEEK IN PARIS.

3. EMBASSY WOULD APPRECIATE ANY FURTHER INFO DEPT CAN PROVIDE. CHARGE IS SCHEDULED FOR INFORMAL MEETING WITH PRES BHUTTO MARCH 28; PRESUME HE WOULD APPRECIATE ANYTHING WE CAN TELL HIM.
